Minutes of the Monthly Meeting, March 23, 2006 held at Ebenezer Baptist Church.

Margaret White covered his report. Margaret said T.D.C.J. workers would be ready to begin work on April 10. Their duties are listed as carpentry and painting. Charles Bobbitt will have windows in place, replace boards and hang doors.

The previous workday on March 18 the people that worked were Dennis Hosea, Lynn Alexander, Cal Webster, Jim Woods, Robert Ellington, Cory Murray, Earl Carter and Velma Bruce. Lynn and Calvin worked again on the 20th.

A vote was taken and the auditorium is to be green as it was before.

The material list is attached. The \$650 cost of the wood deck was removed. The board approved the list with one correction.

The 7 inmates will be fed by the community. Lunch will be served by 12 noon. Donuts and coffee will be served in the a.m. The noon meal should consist of meat, a vegetable, salad, tea, bread and a dessert.

Margaret will pick up donuts on Tues, Wed and Thurs. Joe will provide donuts on Monday. Jim will provide cold drinks and water.

Election of Officers: Bobby Ellington declined re-election as Trustee. Shirley Taliaferro agreed to serve and was nominated by Delma Shelly. Delma S. made a motion to elect Shirley Taliaferro as Trustee for a 3-year term beginning March 2006 ending March 2009. Robert Shiflet seconded the motion. Motion carried. The following agreed to serve and were nominated: President – Joe McDaniel, Vice President – Jim Woods, Treasurer – Judy Ellington, Secretary - Joyce Shiflet; Velma Bruce made a motion to elect the officers as nominated and Evelyn McDaniel seconded the motion. Motion carried.

A workday is scheduled for March 25. The meeting adjourned with a reminder that the next meeting will be on April 20 at 6:30 p.m. at Ebenezer Baptist Church.
